ORDER:

The Hon'ble Minister (School Education, Youth Welfare and Sports Development) has announced in the floor of the Legislative Assembly regarding "Construction of Amenities block and improvements to Gymnastics Training Hall" in SDAT Aquatic Complex, Velachery, Chennai at a cost of Rs.150.00 lakh.

2. In this connection the Principal Secretary / Member Secretary, Sports Development Authority of Tamil Nadu in his letter read above has stated that he has requested the Engineer-in-Chief to furnish a detailed estimate for the above said project. Accordingly, the Engineer-in-Chief, Chief Engineer (Buildings), Chennai Region, Public Works Department, Chepauk, Chennai furnished the detailed estimate for Rs.150.00 lakh along with drawings for construction of Amenities block and improvements to Gymnastics Training Hall in Sports Development Authority of Tamil Nadu Aquatic Complex, Velachery, Chennai.

3. The Principal Secretary / Member Secretary, Sports Development Authority of Tamil Nadu has further stated that the estimate has been prepared based on the Public Works Department schedule of rates for the year 2019-2020. As per detailed estimate, the Amenities block is proposed as RCC framed structure and designed for G+2 and it is proposed to provide isolated footings. The proposed building provides a coach room, Store room, separate change room and toilets for male and female players.

4. Based on the above report / estimate of Engineer-in-Chief & Chief Engineer (Buildings), Public Works Department the Principal Secretary / Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to accord Administrative and Financial sanction for a sum of Rs.150.00 Lakh (Rupees One Hundred and Fifty Lakh only) for Construction of Amenities block and improvements to Gymnastics Training Hall in Sports Development Authority of Tamil Nadu Aquatic Complex, Velachery, Chennai-32.

5. The Government, after careful examination, accord Administrative and Financial sanction for a sum of Rs.150.00 Lakh (Rupees One Hundred and Fifty Lakh only) for Construction of Amenities block and improvements to Gymnastics Training Hall in SDAT Aquatic Complex, Velachery, Chennai-32.

6. The expenditure sanctioned in para-5 above shall be debited under the following head of Account:-

“2204-00 Sports and Youth Services – 104 Sports and Games-State’s Expenditure - JW Grants to Sports Development Authority of Tamil Nadu for establishment of sports complex - 309 Grants-in-Aid-02 Grants for Creation of Capital Assets” (IFHRMS DPC: 2204 00 104 JW 309 02)

7. The expenditure sanctioned in para-5 above constitutes an item of “New Instrument of Service”. The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Principal Secretary / Member Secretary, Sports Development Authority of Tamil Nadu is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form ‘A’ appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of advance from the Contingency Fund will be issued from Finance (BG-I) Department. . The Principal Secretary / Member Secretary, Sports Development Authority of Tamil Nadu is also requested to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2019-20 to Finance (BG-I/Edn-I) Department at an appropriate time without fail.

8. The Principal Secretary / Member Secretary, Sports Development Authority of Tamil Nadu, on receipt of the cheque, shall deposit it in the bank in which the P.D.A/c is maintained, with a challan in triplicate, duly indicating thereon, the head of account “K Deposits and Advances (B) Deposits not bearing interest – 8443 00 Civil Deposits – 800 Other Deposits – CH Deposits of Sports
